### **Metro Roundtable Business Meeting**

1. Welcome/Introductions (1 min.)

The meeting was called to order by Chair Lisa Darling at 2:01 pm.

- 2. Approval of March 14, 2024, Meeting Summary (1 min.)
  - It was moved to approve the March 14, 2024, MRT Meeting Summary with correction under CWCB update changing "BLM" to "Bureau of Reclamation". Motion approved by acclamation.
- **3. Agenda: additions or changes (1 min.)** The Legislative update was moved to the beginning of the agenda and the Drought Resilience Project Update will be presented in May.
- 4. Public Comment (5 min.) None.
- 5. Legislative Update (Kelly Romero-Heaney, DNR Representative) (25 min.)

About 700 bills related to DNR have been introduced. A key priority in respect to water is the mission critical projects bill, HB24-1435 Water Projects Bill, including \$23M in Water Plan Grant funding. Bills that have been signed and are still under review were discussed. Status was provided on two bills introduced to address dredge and fill gaps. There has been more revenue than anticipated through Proposition DD. They are going back to the legislature, due to Tabor restrictions, to address the excess revenues. Legislation has been introduced regarding abandonment protection for coal plant closures. It went before the Senate Ag Committee yesterday and passed unanimously.

- 6. WSRF Committee (Kim Gortz & Sam Calkins) (5 min.)
  - 1. A review was provided on the status of the applicants preparing to submit WSRF applications into the CWCB portal. Shane Wright with Lincoln Hills Cares was introduced and provided an update on their application with an increase in their MRT WSRF funding request from \$5,000 to \$15,000. The full project costs are \$137,000. \$100,000 has been secured. They are working to get the final \$37,000. \$15,000 from MRT would go toward the funding gap.

#### HB24-1435 Water Projects Bill

- Introduced last week. Appropriation highlights -
  - \$23.3M for Water Plan Grants for next fiscal year
  - o A request for flexibility in the ARPA federal technical assistance programs.
    - Originally there was \$2.5M for Local Capacity Grants (direct grants for grantees to hire contractors to apply for federal grants) and \$2.5M for CWCB Technical Assistance (where grantees use the CWCB hired contractor).
    - The proposed action would give CWCB flexibility to respond to market demands and award the remaining 2.3 million in the Technical Assistance bucket to either bucket in the program rather than capping each at 2.5 million.
  - \$2.0M to extend the Turf Program.

#### **TLC Challenge**

• Governor Polis and the Colorado Water Conservation Board (CWCB) <u>announced</u> the second year of the <u>Transformative Landscape Change (TLC) Challenge</u> program. This is a partnership with Resource Central who is running the program. If your water utility or municipality is interested visit <u>Resource Central's website</u> to submit an application - due by June 1, 2024. The challenge is for local communities to reimagine their public spaces and embrace waterwise landscaping and convert water-intensive landscapes into climate-appropriate, low-water-use, and attractive spaces. 15 applications will be selected to get up to 2,000 sq ft of turf and receive low-water xeriscape plants to plant.
