David Riordon with Colorado River Surfing Association attended a discussion on the Water Plan. His organization is considering working with the Greenway Foundation to pursue a grant to create a task force to address river flow and use matters. Asked for RT feedback on this idea. MRT would need to check the BIP. Riordon expressed concern with the Army Corp. information on gate changes in the water that is sent through their Listserv. CO River Surfing Association asked Army Corp. if the information could be made public. The response was that the information is "need to know only." There is not an Army Corp. representative on the MRT.

Jarod Henrickson was in attendance. He is a third-generation farmer with 1300 acres in Weld County. He came recommended to serve as the new MRT Ag Representative. This is a Statutory seat. Only statutory members can vote on this position.
