 - 2. WSRF 1-page summaries are due March 15 for Cycle 1 of 2022. Please share information on the grant open period. There is no longer a state fund to draw from. CWCB is updating its grant and loan portal. They are adding and testing the WSRF and PEPO grant online modules.
- 6. Statewide Phosphorus-Free Fertilizer Initiative (Steve Lundt, Metro Water Recovery) (20 min.) Initiative to educate Coloradans on impacts of fertilizer use. Goal is to change behavior of lawn management. Showed list of entities joining coalition in support of this effort. They are asking for feedback and encouraging groups to join and share the P-Free information.

The BIP is available on engagecolorado.gov. BIP and comments will be loaded onto the SPB website soon. They are preparing the Water Plan update for review June 30th and identifying common themes across basins.

There was a BIP discussion in the M&I committee meeting. They came up with a list of 10 project ideas and prioritized them by ranking. Other subcommittees may want to engage in this same exercise. MRT can take subcommittee lists and develop a combined list of priorities and begin encouraging these types of projects.
