#### 9. IBCC Update (Jim Yahn & Sean Cronin - 5 Min.) (Link to IBCC Webpage)

Updated provided by Jeff Rodriguiz. At the June 8th IBCC meeting Kelly Romero-Heany provided a CO River update that opened an interesting dialogue on the roll IBCC has in legislative topics. CWCB and IBCC PEPO presented results from the C-9 Summit Roundtable Survey. Key highlights include that people were most interested in hearing from experts, panels, workshops and networking (in that order). The Survey also showed that a few topics like Colorado River, Drought Resilience, Climate Change, Funding and Water Conservation were of higher interest. Based on those results, other input CWCB has collected, and the number of topics that can fit into a day-long event, CWCB staff shared a very rough draft of the forthcoming November 14, 2023 C-9 Summit. #### 11. Round Table Member Comments (5 min)

John Kolanz mentioned the May 25<sup>th</sup> decision by Water of the United States (WOTUS) which is integral to BIPs. WOTUS reduced Clean Water Act jurisdiction. What had been regulated by the Federal Government will now need to be addressed by states and local municipalities. At the State level, Colorado will look to develop a permitting program to address those waters that lost protection due to this decision. Members were encouraged to follow this.
