## CWCB Board meeting: May 17-18, 2023 Highlights

- b. Timeline starts now leading to interviews, draft plan release leading to discussion at a retreat in August
- IV. Chatfield Reallocation Project Environmental Pool Agreement
  - a. Sale approved: essentially like a conservation easement on 500 AF of storage space to be used for water to be used for environmental purposes. The funds came from The Greenway Foundation and Denver Water (\$3,050,000). CWCB would still be responsible for O&M cost of that storage space.
- V. Fish & Wildlife Resources Fund-Criteria Update
  - a. New version of guidelines approved
- VI. Colorado River Update
  - a. 2023 Drought Response Operations Plan approved and focused on recovery of Blue Mesa and Flaming Gorge: no additional releases planned
  - b. Implementation of the SCPP by the UCRC
    - i. Because of Congressional approval was in Dec of 2022 there was not much time to administer
    - ii. Confusion on the application process
  - c. Main focus is centered on the fact that the upper basin states are limited each water year on the weather. The current shortages in Lakes Mead and Powell are because of the continual over use of the lower basin states.
    - i. Continued push for the lower basin states to be held accountable for evaporative and system losses just like Colorado does.
  - d. Colorado will continue to do more to conserve and protect all of it's water resources
